## **NOTIFICATION**

No. 232 – 93 /PWT:- In exercise of the powers conferred by Khyber Pakhtunkhwa Police Welfare Fund Rules-2014 read with Chapter-II, Rule-6 (e) and recommendations/approval of Police Welfare Fund Board in its meeting held on 09.03.2023, the Provincial Police Officer Khyber Pakhtunkhwa is pleased to introduce structural changes in renaming, management, contributions, resource generation, disbursements of Welfare Funds and to increase the spread of funds for the wellbeing of Police personnel in Khyber Pakhtunkhwa Police Welfare Fund Rules-2014, as under:-

- a. Introduction of software and digitization for the management of Welfare Fund.
- b. Rule-18 Dowry Charges (Bridal Gifts) Dowry Charges is renamed as Bridal Gifts and hereby increased upto Rs.100,000/- for the marriage of first daughter of beneficiary from BS-1 to 14 and it shall remain Rs.30,000/- for Second daughter.
- c. <u>Rule-19 Widow Stipend:-</u> Widow stipend is hereby enhanced from Rs.7,000/-Per month to Rs.25,000/- per month.
- d. <u>Rule-20 Burial Charges</u>:- Burial charges is hereby enhanced from Rs.30,000/- to Rs.50,000/- on the death of a beneficiary during service upto BS-16.
- e. Rule-17 Medical Charges:- The Medical Aid will be provided as per following detail:-

### f. Rule-16 Scholarships:-

- The percentage set as benchmark for award of Scholarships has to be raised to ensure competition, for FA it would be 70% and for FSc it would be 80% minimum. For Graduation Classes, GPA for Science students must be minimum 3.4 and Graduation for Arts Classes GPA should be 3.0 minimum.
- The education at prestigious professional educational institutions be fully funded. For this purpose, HEC ratings for first five institutions providing education in the field of engineering, Medicine, IT, CA/ICA, Business Administration & AI Technology be taken as PPIs. Moreover, the prestigious institution in Khyber Pakhtunkhwa will also be included in addition to this list i.e. KMC, Ayub Medical College, UET Peshawar & GIKI etc. This list will be issued for every academic year by office of Additional IGP HQrs: through a Notification.
- Focus be shifted more on Nursing Institutes, Technical Colleges, Agricultural and Commercial Sector in addition to Medical and Engineering Universities.
